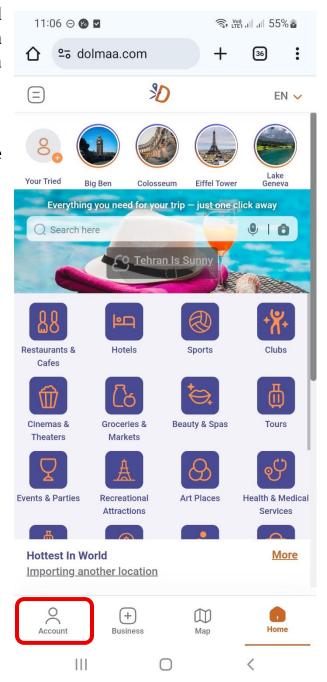


Business Registration Guide on the **Dolmaa Website**

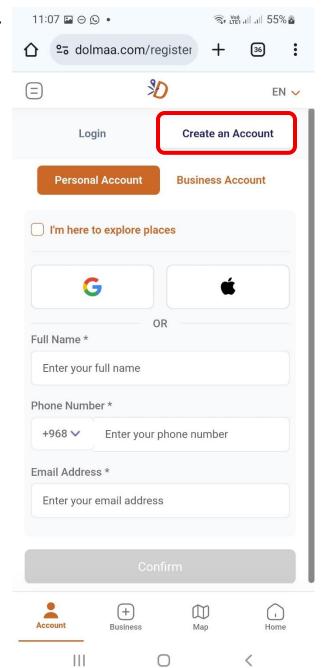
Go to www.dolmaa.com website and click on the account option to add a business, you must first create a business account.

Select the "**Account**" option from the bottom menu.





Select the "Create an Account" option. 11:07 \square \bigcirc \bigcirc •





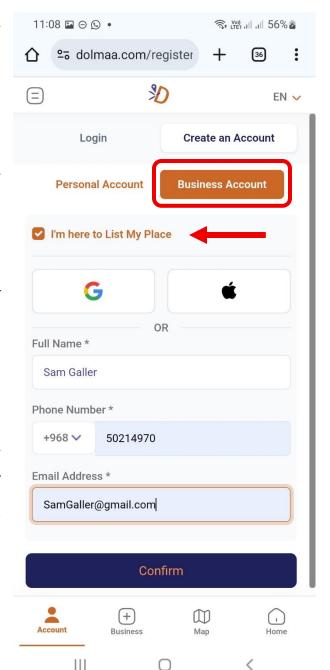
Choose the "Business Account" option and tick the *I'm here to list my place* checkbox.

Please fill in all fields (Full Name, Phone Number and Email Address).

Enter your Phone Number with Country code. After filling in all fields, click the confirm button.

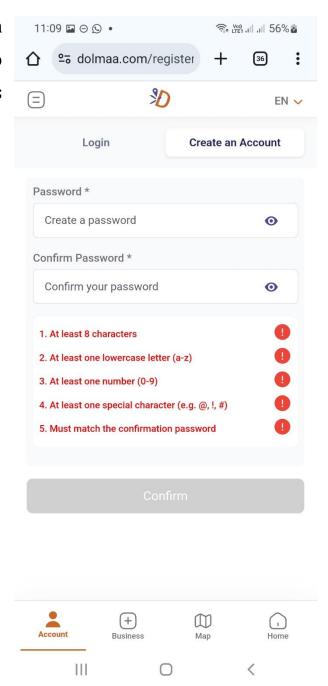
In the "Phone Number" fields, a drop-down list will open where you can select your option. You can also search for the word you want.

Note: The confirm button is inactive until you fill in the necessary information.





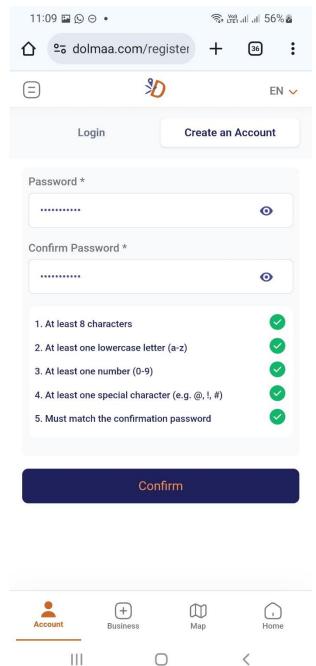
Fill in the "Password" and "Confirm Password" fields, and make sure to follow the five password guidelines shown below.





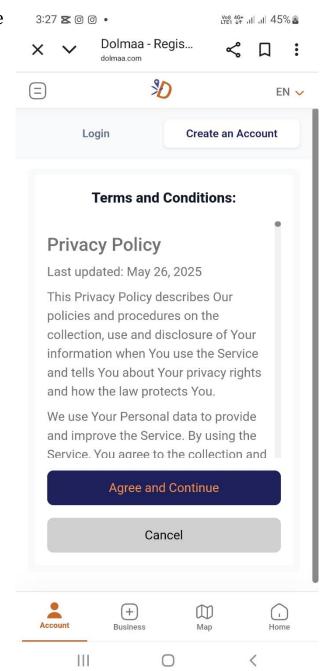
As you can see, all the password requirements have been met, and a green checkmark appears next to each one.

Following all these requirements helps strengthen the security of your password.





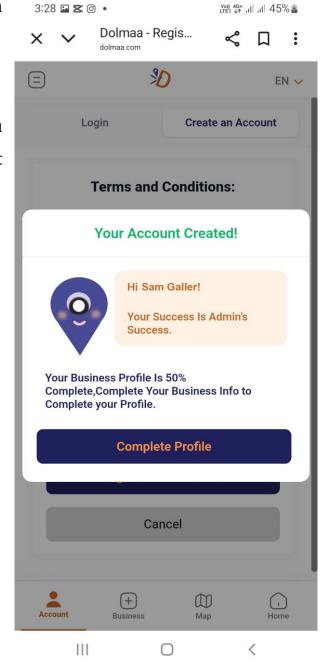
Read the Privacy Policy and press the "Agree and Continue" button.





Your account has now been successfully created.

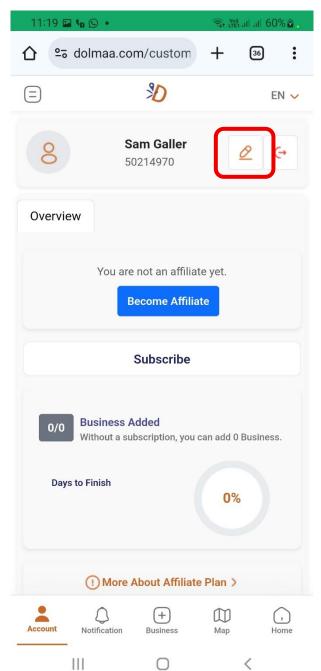
By clicking "Complete Profile", you can access your dashboard and start adding your business.





After clicking "Complete Profile", you will be redirected to your user dashboard.

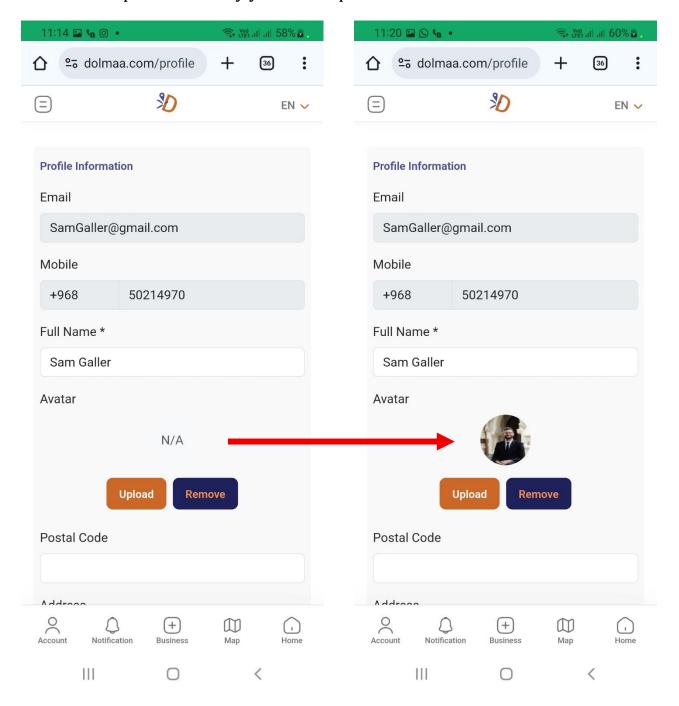
From there, click "**Edit**" to complete your profile information and add a profile picture to your account.





On the "Edit Profile" page, you can view and update your personal information.

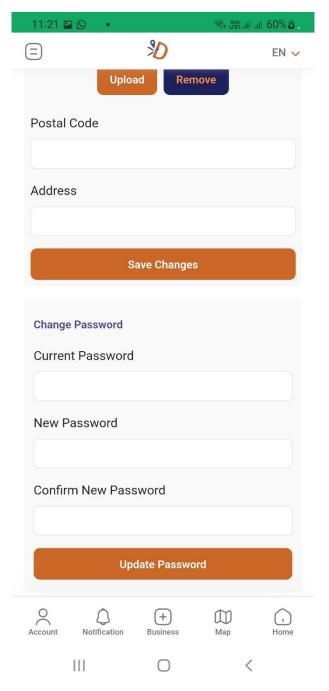
In the "**Avatar**" section, you can upload a profile picture for your account. You can also complete or modify your other personal details.





In the "Change Password" section, you can update your password by first entering your current password in the "Current Password" field, then typing your new password in the "New Password" field, and confirming it in the "Confirm New Password" field.

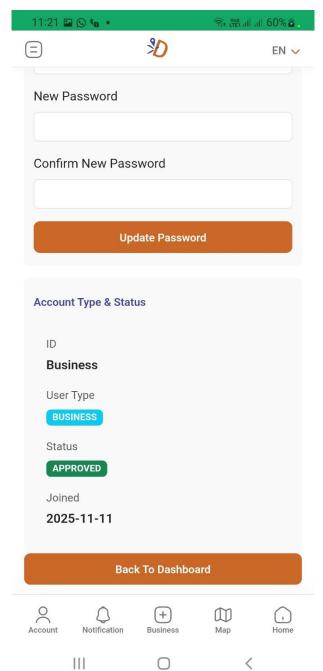
Click "**Update Password**" to save your changes.





In the "Account Type & Status" section, you can view your account type and the date you joined the platform.

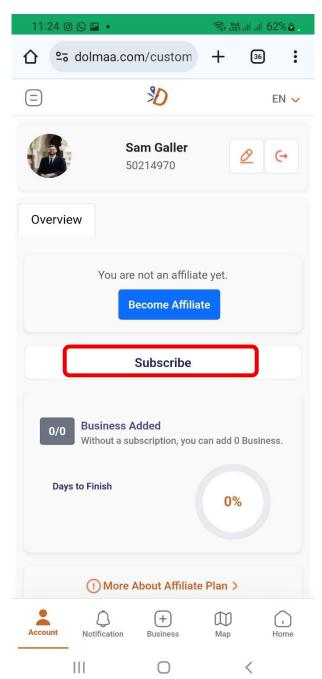
At the bottom of the page, click "Back to Dashboard" to return to the previous page.





On your dashboard, you'll notice that no businesses have been added to your account yet.

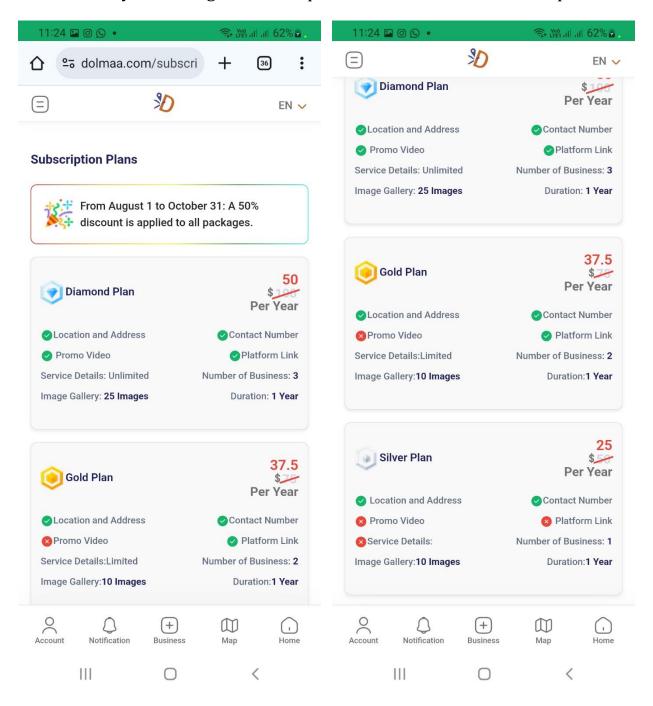
You can click the "**Subscribe**" button to open the subscription page and choose one of the three available plans.





Each "**Subscription Plans**" includes a short description below it, explaining its features and benefits.

All subscription plans are valid for one year, and you can easily compare their differences by reviewing the details provided at the bottom of each plan.

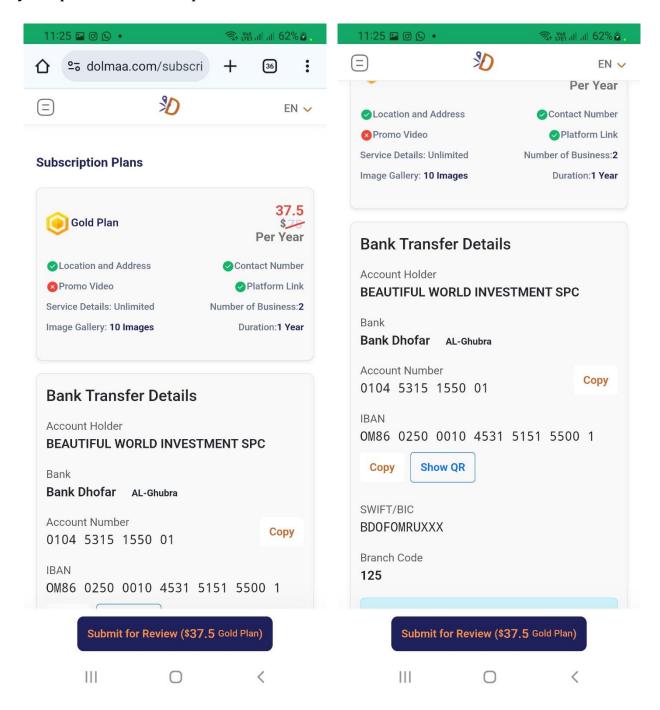




For example, let's select the "Gold Plan".

The plan's price and other details are displayed on the screen.

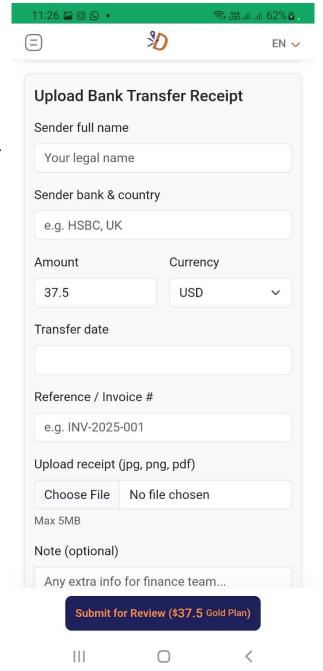
Below that, you'll find a form containing the required information to complete your purchase of this plan.





Enter the required information in the provided fields.

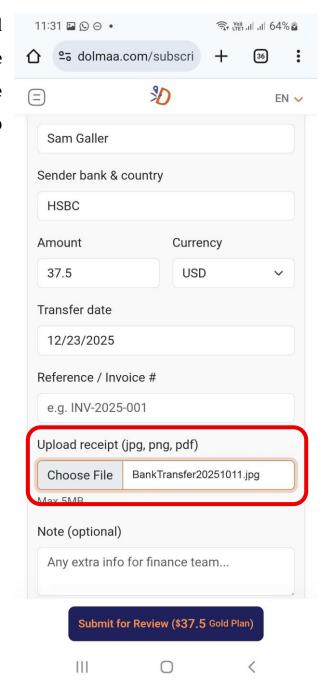
Upload your bank transfer receipt in the "Upload Receipt" section, and if necessary, add any additional notes in the Note box.





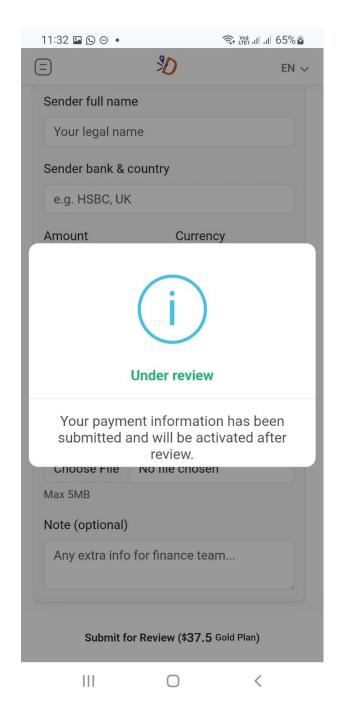
After completing all the required

proceed.

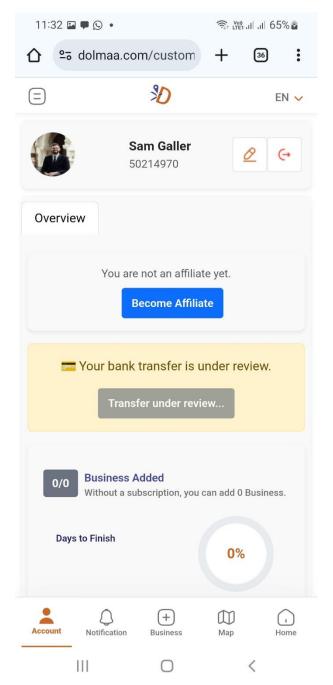

Payment details and bank transfer receipt will be reviewed and verified by the website's finance team.



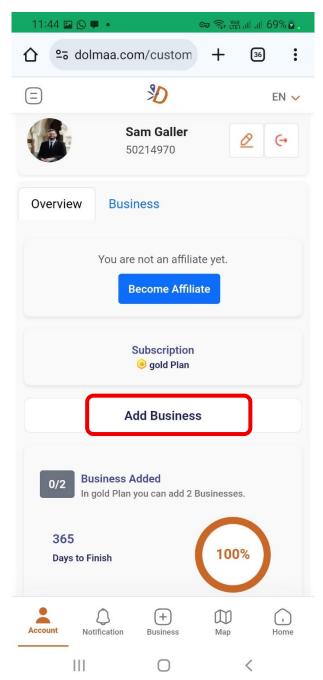




After payment and bank transfer have been approved, you can view purchased subscription plan in the dashboard.

According to the plan you have purchased — in this case, the "Gold Plan" — you are allowed to add up to "two businesses".

To add your business, simply click the "Add Business" button.

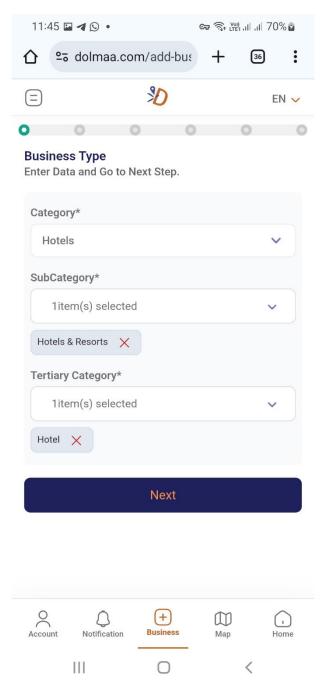




In the first step of adding a business, select the main category and related subcategories that best describe the business.

For example, add a *Hotel* as a sample business.

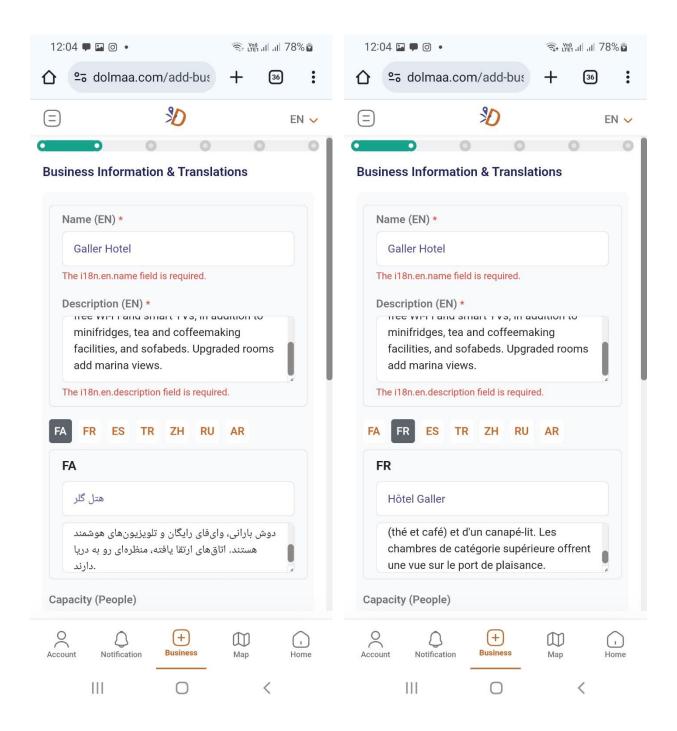
Note: Fields marked * are required.





In this section, enter the "Business Name" and provide a brief "Description" of the business.

It is also possible to add the business name and description in other languages: "Persian, French, Spanish, Turkish, Chinese, Russian," and "Arabic."

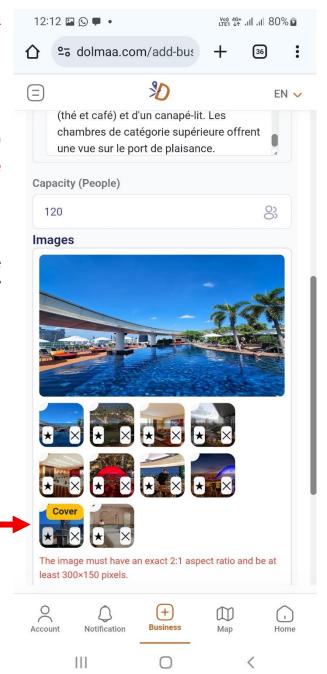




Next, enter the "Capacity" and upload up to "10 images" for your business.

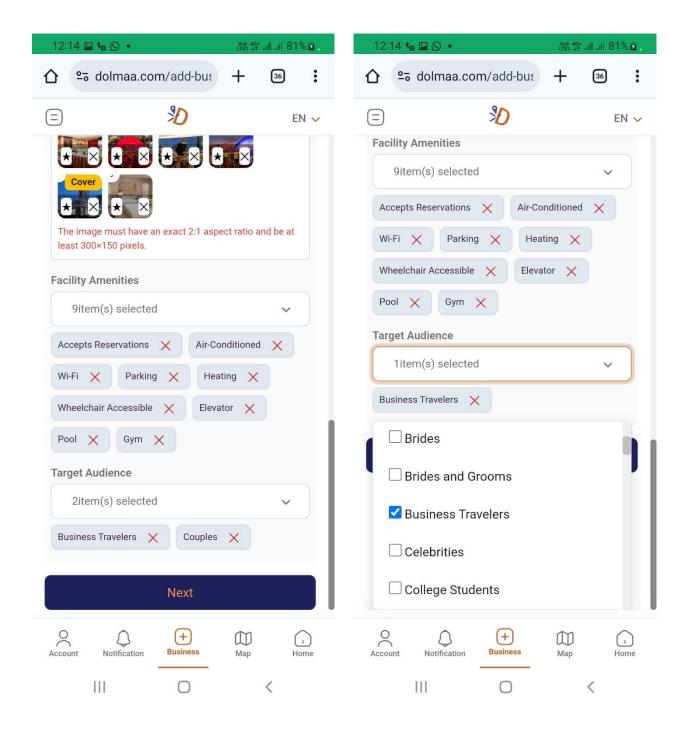
Note: The image must have an exact 2:1 aspect ratio and be at least 300×150 pixels. And make sure to select all the images from your gallery "at once",

You can also choose one of the uploaded images as the "cover photo" by clicking the "star icon".





In the "Facility Amenities" and "Target Audience" fields, you can select multiple options by clicking on the drop-down list. Then press "Next" bottom.

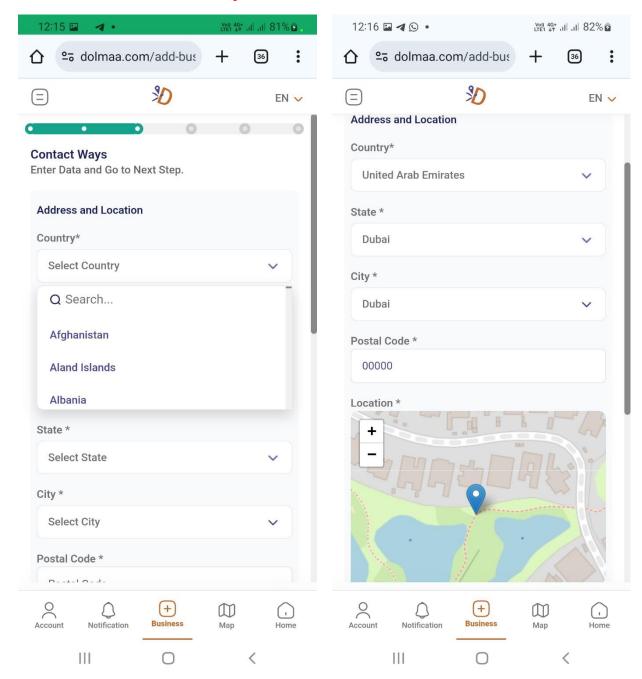




Enter your business address including country, state, city and postal code.

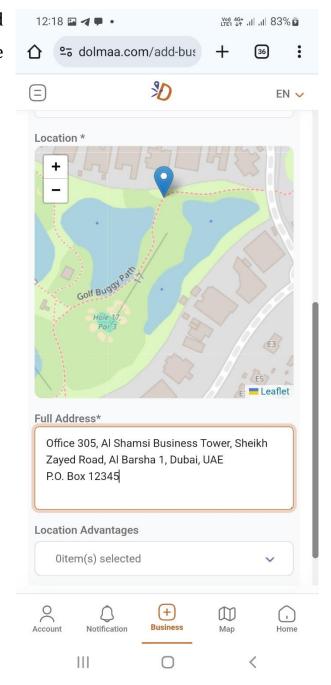
In the "Country", "State", and "City" fields, a drop-down list will open where you can select your option. You can also search for the word you want.

Note: Fields marked * are required.





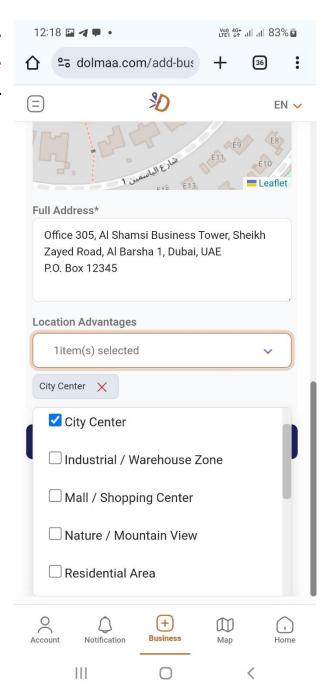
Locate your business on the map, and in the "Full Address" field, enter the complete address of the business.





In the "Location Advantages" section, select one or more options from the drop-down list that best describe your business location.

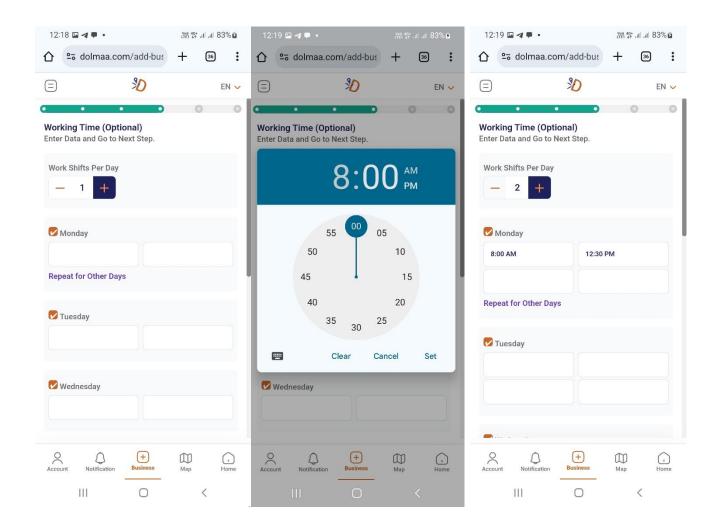
Then press "Next".





In the "Working Time" section, it's possible to define the business's service hours and set up one or more work shifts for each day.

This section is "optional".

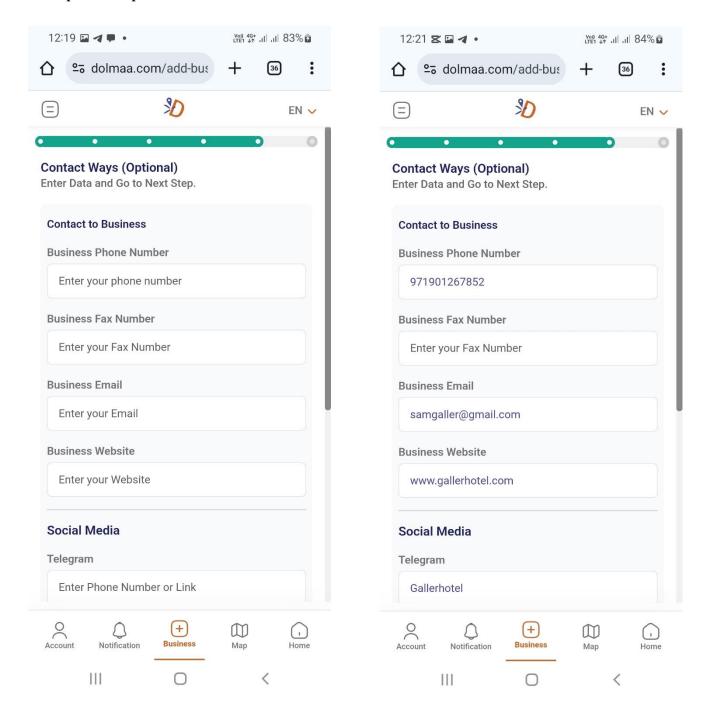


If a specific day is closed, by unchecking the box next to the name of that day, the ability to enter working hours for that day will be disabled.



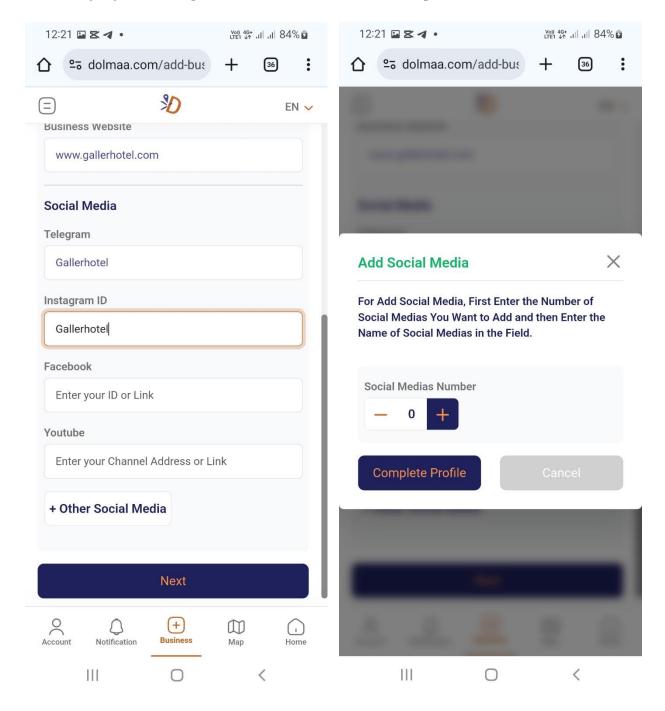
Enter ways to contact your business, such as phone numbers, email, and social media.

This part is optional.

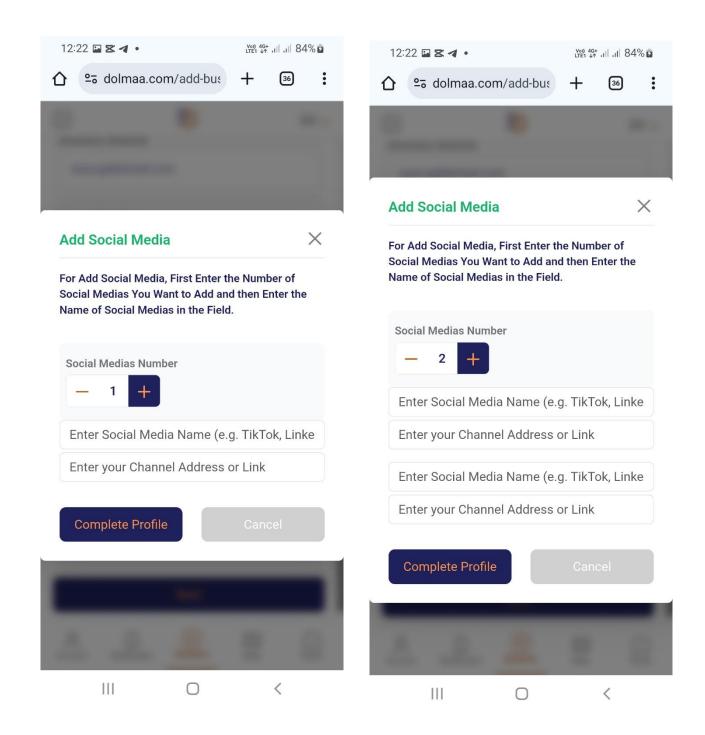




If the social media you want is not found in the available fields, you can enter it manually by selecting the "**Other Social Media**" option.



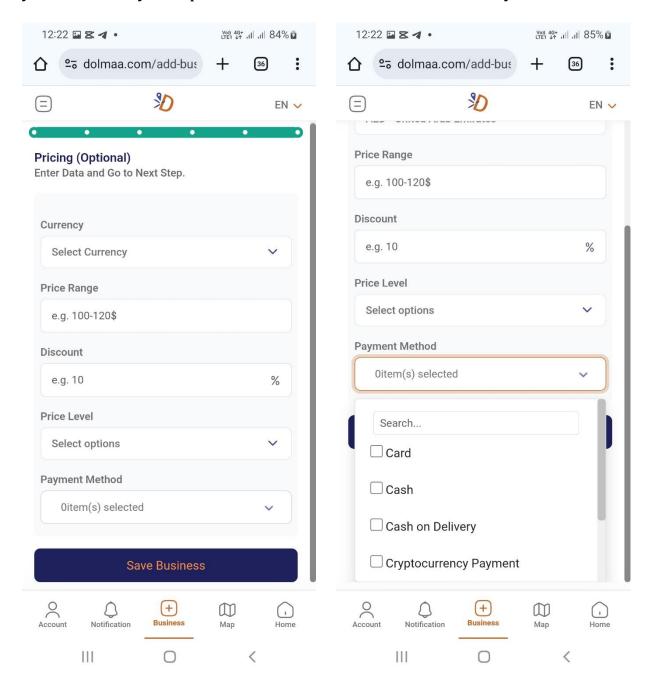




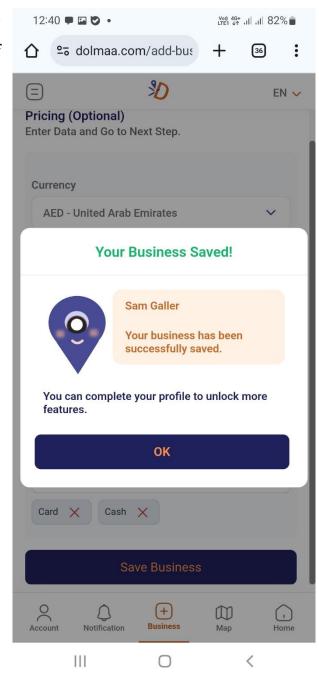


Enter information about your business' pricing, discount amount, currency, and payment methods.

In the "Currency" and "Price Level" fields, a drop-down list will open where you can select your option. You can also search for the word you want.

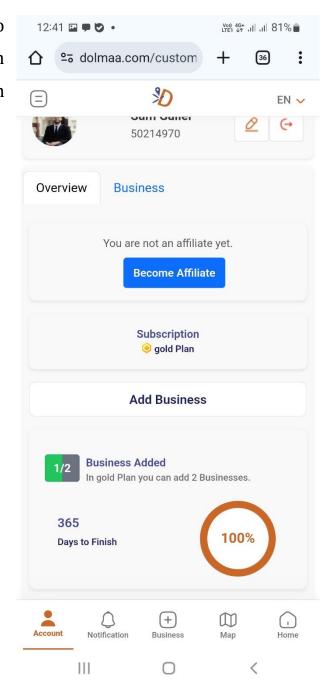








As you can see, one of the two businesses available for registration under the "Gold Plan" has been successfully added.
